Disclosure Agreement and Survivorship Designation

I/We, the current member(s) and new joint members(s) acknowledge that membership at Nymeo comes with certain ongoing responsibilities. By signing this document, my joint members(s), if any, and I/we agree to abide by the disclosed terms and conditions of all accounts or services that I/we receive at Nymeo and the terms and provisions of the Membership and Account Agreement. These terms and conditions are disclosed in accordance with applicable state and federal laws and are provided in the disclosure and agreement forms. The survivorship designation on my primary savings account applies to all other joint accounts with the same joint member unless specifically designated otherwise for a particular account.

Security Interest: I/We acknowledge and pledge to Nymeo a statutory lien in my/our shares and dividends on deposit in all joint and individual accounts and any monies held by Nymeo now and in the future to the extent of any loan made and any charges payable. The statutory lien does not apply to shares in any Individual Retirement Account.

I/We acknowledge and pledge to Nymeo a security interest in the collateral securing loan(s) that I/we have with Nymeo now and in the future, including any type of change or increase; and any proceeds from the sale of such collateral and of insurance thereon not to exceed the unpaid balance of any loan(s). This security interest in collateral securing other loans does not apply to loan(s) on my/our primary residence.

Federal law requires all financial institutions to obtain, verify, and record information that identifies each person who opens an account, including joint members and authorized signers. What this means for you: When you open an account, we will ask you for your name, address, date of birth, and other information that will allow us to identify you. We may also ask to see your driver's license or other identifying documents. It may be necessary for Nymeo to restrict account access or delay the approval of loans pending further verification. Property may be transferred to the appropriate state if there has been no activity within the time period specified by state law.

All joint account members/signers are considered equal owners and joint tenants with the right of survivorship.
